Eyes on Ice (QAIHC)

"Eyez on Ice" is a culturally safe resource package designed to assist health professionals and families to support people impacted by problematic substance use, particularly crystal methamphetamine (ice). The package was produced by the Queensland Aboriginal and Islander Health Council (QAIHC) and the AOD- OUR-WAY Content Advisory Group.

Fetal Alcohol Spectrum Disorder (FASD)

A package of links to recommended resources, videos, webinar recordings and organisations to support workers when working with people affected by Fetal Alcohol Spectrum Disorder (FASD).

First Nations

A package of resources, eLearning modules, recorded webinars and videos as part of the delivery of training and cultural capacity building activities for both Aboriginal and/or Torres Strait Islanders and non- Indigenous workers.

Fundamentals of Suicide and Suicidality

A toolkit offering eLearning modules and resources to help workers understanding suicidality, communicate effectively about it, and support individuals experiencing it.

Inhalants (Dovetail)

A package of resources that can assist workers to respond to young people who use inhalants.

Insight Check Tools

A series of brief, modular job-aids designed to assist workers to have structured, collaborative conversations with someone about their alcohol and/or non-prescribed drug use. They have been intentionally designed as a mix of 'information brochure' and 'quided brief intervention' all-in-one.

High risk medicines

MDMA

A package of tools, factsheets, flowcharts, eLearning modules and videos designed for health and community service workers who engage with people who use methamphetamine.

This toolkit contains a range of PHN publications and resources designed to assist GPs in Queensland to provide better quality care to patients experiencing opioid use disorder.

Police and Court Diversion - Service Provider resources

A toolkit for Police and Court Diversion service providers with training, resources and job aids to effectively deliver the program in Queensland.

Pregnancy and Early Life

A package of brief intervention eLearning modules, resources and guidelines for health workers who support pregnant and parenting women.

The Indigenous Risk Impact Screen (IRIS)

A package of eLearning, resources and videos on the IRIS screening and brief intervention tool. This tool has been validated to meet the specific needs of Aboriginal and or Torres Strait Islander people. It is designed to be used by both Aboriginal and or Torres Strait Islander and non-Indigenous workers in a wide variety of contexts including primary healthcare, community health, Emergency Departments and other health and community care settings.

The Queensland Opioid Treatment Program (QOTP) Prescriber Course

Self-paced eLearning modules and accompanying guidelines and resources for GPs and Medical/Nurse Practitioners who are seeking to become authorised to prescribe opioid dependence treatment in Queensland.

Trauma Informed Care

Training for Non AOD/MH Workers

NB: Workers employed within specialist AOD and mental health settings are advised to skip these modules and proceed directly to Learning Levels 1 – 5 where concepts, theories and skills are explored in greater detail.

Workshops

Insight deliver a range of face-to-face and online 'workshops for Queensland-based workers. All workshops are free and bookings are essential.

Requests for training tailored for your individual organisation or teams are considered on a case-by-case basis and fees usually apply. For more information see our <u>fee-schedule</u> below.

Level 1 - Core AOD Knowledge

AOD and the Brain

This one-day workshop explores the effects of different substances on the brain and body, equipping participants with the knowledge and skills to support informed decision-making and individualised treatment planning.

What will be covered:

- Understanding the effects of stimulants, depressants, and hallucinogens on the brain and body.
- Assessing neurobiological stages such as intoxication, tolerance, and withdrawal to guide treatment adjustments.
- Applying knowledge of neurotransmitters impacted by AOD use to create tailored treatment plans.
- Communicating effectively with people about how substances affect their brain and body to empower informed choices.

Cultivating Worker Wellbeing: Building resilience in AOD

Whilst clients are frequently taught about the importance of stress management, lifestyle balance and utilising support, many AOD and mental health workers do not apply these same skills to enhance their own personal resilience. This workshop aims to equip AOD and mental health workers with a greater awareness of the signs of burnout including practical things you can do to if it occurs.

What will be covered:

- · Understand the difference between burnout and resilience
- · Apply practical skills for building professional and individual resilience
- Develop an individual resilience plan in a changing AOD landscape
- Know where to access further support to reduce symptoms of burnout as an AOD worker

Culturally Safe AOD Practice

This full day workshop focuses on enhancing worker's culturally safe alcohol and other drug practice when working with Aboriginal and or Torres Strait Islander peoples, their families and communities.

By the end of this workshop learners will have increased knowledge and awareness of:

- the impact of colonisation on the social determinants of health for Aboriginal and Torres Strait Islander people.
- key concepts of Aboriginal and or Torres Strait Islander health including Social and Emotional Wellbeing.
- the prevalence and rates of substance use amongst Aboriginal and Torres Strait Islander populations.
- key practice principles and approaches when working with Aboriginal and or Torres Strait Islander peoples, families and communities
- resources and tools which can assist in culturally safe engagement, screening, assessment and intervention
- how to build and/or enhance organisational and workplace cultural safety.

Level 2 - Core AOD Skills

Using Motivational Interviewing in AOD Practice:

This workshop, based on the principles and practices of Motivational Interviewing (MI), offers an opportunity to learn skills for having MI-consistent conversations across different stages of client readiness for change.

What will be covered:

- Understanding the MI approach and its relevance in supporting people experiencing AOD issues.
- Exploring the spirit of MI: partnership, acceptance, compassion, and empowerment.
- Techniques for creating a safe and non-judgmental space for open conversations.
- Techniques for engaging people who are at different stages of readiness in relation to their problematic AOD use
- Tools and resources for continuous learning and application of MI.

AOD Harm Reduction

This informative one-day workshop focuses on equipping participants with practical strategies, resources, and techniques to conduct effective harm reduction conversations with clients. Whether you are new to harm reduction or looking to update your skills, this workshop will provide valuable insights and practical tools.

What will be covered:

- Overview of harm reduction principles and person-centred approaches and their importance in providing effective substance use support.
- Techniques and strategies for providing tailored harm reduction conversations.
- Opportunity for hands on exposure to a range of equipment and harm reduction materials associated with drug use and simulated illicit drugs.
- Specific harm reduction practices for different substances and routes of administration.
- Introduction to a range of job aids and case studies to develop practical understanding and application of skills.
- Customising harm reduction information to suit diverse client characteristics and needs.
- Options for accessing up-to-date harm reduction resources.
- Opportunity to participate in skills-based scenarios as both a service user and service provider.

Relapse Prevention and Management

This workshop equips participants with skills to support people in managing relapse through tailored conversations, a flexible framework, and person-centred planning that adapts to evolving needs.

What will be covered:

- The purpose of Relapse Prevention and Management (RPM) and its essential components.
- How to adopt an appropriate RPM stance to support tailored and engaging conversations.
- Constructive approaches to averting and addressing lapse or relapse, which encourage continued service engagement.
- Using a flexible framework to guide RPM conversations effectively.
- Recording RPM plans to reflect a person's needs and preferences while meeting service requirements.
- Updating and adjusting RPM plans to align with a person's evolving goals and circumstances.

Cognitive-Behavioural Therapy 4 AOD: Foundation Skills

This two-day workshop focuses on the foundational aspects of Cognitive-Behavioural Therapy (CBT) and its application with individuals impacted by problematic alcohol and other drug use. Designed for workers who provide direct counselling, the workshop aims to build foundational knowledge and practical skills in CBT techniques.

What will be covered:

- Key concepts, structures, and elements of CBT tailored for substance use disorders.
- Techniques in conducting a functional analysis.
- Developing a CBT-based formulation and formulation-linked plan.
- Skills in applying cognitive techniques.
- Overview of behavioural strategies.
- Developing collaborative learning experience

Level 3 - Specialist AOD Practice

Assessing and Managing Withdrawal (Nursing and Medical)

This one-day workshop is tailored for nurses and medical professionals who may be directly involved in assessing and medically managing alcohol and drug withdrawals in any setting. The content is crafted to deepen understanding and enhance practical skills, ensuring safe and effective care for individuals undergoing planned or unplanned withdrawal.

What will be covered:

- Overview of withdrawal syndromes associated with a range of substances.
- Physiology and psychology of dependence and withdrawal.
- Training in assessment tools and techniques for identifying withdrawal symptoms.
- Evidence-based approaches to managing withdrawal symptoms.
- Pharmacological and non-pharmacological interventions.
- Strategies for developing individualised withdrawal management plans.
- Skills for the management of deterioration.

'Let's Practise' Series

Insight's "Let's Practice" series offers short, online, skills-focused training sessions that cover a broad range of AOD-related practices. These sessions, available for Queensland-based workers, last between 30 to 90 minutes and include hands-on activities to assist workers in enhancing their practice. Participant numbers are limited, and registration through the Insight workshop page is essential.

Learning Portals

Insight's Learning Management System (LMS) has been configured to allow external organisations and programs - including those who provide training for other states and territories - to curate their own private, dedicated 'Learning Portals' customised and restricted specifically for their employees or target learner audiences.

Features

Learning Portals have the following features:

- Customisable headings, banner image, introductory information and logos.
- The ability to host a mix of eLearning modules, training videos, webinars, downloadable resources, and links to other websites. These items can either be drawn from Insight's existing learning suite or supplied by the customer (subject to terms and conditions).
- Customised certificates and post-completion evaluation surveys for any hosted eLearning modules.
- Learner reports (specific to your Learning Portal) via csv export.
- Reporting dashboards for Learning Portal Managers for enhanced visualisation of learner characteristics and training completion data.

Learning Portal access is determined through the learner's registration details when they sign-up for an Insight account and can be organised according to:

- · Individual email addresses,
- Organisational email addresses,
- Hospital and Health Service region (currently available in Queensland only), and
- State or territory.

Reporting

Appointed "Learning Portal Managers" from customer organisations receive administrative access to view and export all of their individual learner details, training completion rates and evaluation data for modules housed within the Learning Portal. New features include dashboards filter reports which enable organisations to view and visualise learner characteristics and training completion data. These reports are available in both pdf and csv exports.

Fees

Fees are calculated according to organisational type and location. They cover initial portal set-up, training for Learning Portal Managers and ongoing customer/learner support during business hours.

Whilst linked Insight modules are hosted free-of-charge, additional fees apply for hosting the customer organisation's own modules charged on a fee-per-module-per-month basis and are subject to terms and conditions.

New modules can be also developed and/or existing modules customised with fees determined on a case-by-case basis depending on the time and resourcing required. Please contact us to discuss further.
